#### 1.4 Matters Arising

Ms. Bernadette Cullen, Chief Executive informed the Board that she contacted Mr. Dalton Tattan, Assistant Secretary DES, who will raise the Board's concerns regarding the lack of out-of-hours support for critical incidents with the Department of Education and Skills, he will revert to TETB in due course. It was suggested that a reminder be sent to Mr. Tattan if no response is received in the next two weeks.

# 2. Training - Code of Governance

Chief Executive, Ms. Bernadette Cullen commenced the second induction session to members on the Code of Corporate Governance for ETBs 2019. A copy of the presentation was provided to all members.

The aim of the session was to enable the Board to have: an understanding of TETB's Strategy Statement 2018-2022; consideration of the role and functions of the Board; the role and function of the Chairperson; Code of Corporate Governance for ETBs; Risk Management; Freedom of Information (FOI) and the General Data Protection Regulation (GDPR). Ms. Cullen highlighted the Board of the significance of TETB's values: Inclusive, Innovative, Professional, Respectful and Transparency. These values should be at the core of how the Board and staff operate. Ms. Cullen also outlined the Strategic Priorities and Goals for 2018-22 and provided examples of how TETB is currently working to achieve these goals whilst acknowledging the on-going challenges in terms of resources, funding, geographical spread of the county, etc. The Role of the Chairperson was also outlined and attention was drawn to the Statement of Internal Control which is signed by the Chairperson and reported to the Minister.

Director of OSD, Mr. Frank Bermingham delivered the 'Risk Management' section of the session. This session focussed on Section 7 of the Code of Governance. Mr. Bermingham outlined what risk management involves and why it is important for the Board. While risk management will ordinarily be devolved to the Audit Committee, the Board has an oversight role and must review material risk incidents and note or approve management actions, as appropriate. The processes on how TETB manages risks feed into the internal controls and the Statement of Internal Control referred to earlier. Mr. Bermingham described the current risk management procedures. TETB manages risks in accordance with the process outlined by Irish Public Bodies (IPB). The Corporate Risk Register reflects the main risks from each area i.e. FET, Schools and Administration. The Board should ensure that that the Executive meets the obligations of risk management and that TETB is compliant.

Head of Corporate Governance, Ms. Bernie Harty delivered the final section of the session, 'Data Protection and Freedom of Information'. Ms. Harty described the legislation and highlighted some of the key points to consider. Ms. Harty stressed the need for integrity and confidentiality and the collective responsibility TETB has in order to demonstrate compliance with the legislation. Ms. Harty emphasised the importance of record keeping and reminded

members that every record 'in the possession of TETB is covered by FOI. The Board were informed of the consequences of non-compliance, for example, data breaches, financial penalties and negative publicity. Ms. Harty directed members to the Data Protection and FOI sections on the TETB website where policies and procedures including the Data Protection Policy and Data Breach Protocol are published. Members should inform Ms. Harty immediately if they are aware of, or suspect a breach. Ms. Harty also reminded members that she can be contacted directly with any concerns or queries they may have.

#### 7.1 Key Operational Matters

With regard to the Chief Executive's Report, Ms. Bernadette Cullen advised of the following key matters:

- ✓ ETBI plan to roll out Code of Governance training for Chief Executives and Chairpersons in November/December 2019. Full Board training is envisaged to happen between January to May 2020, delivered in regional clusters.
- ✓ In 2020 Quality and Qualifications Ireland (QQI) will commence its inaugural statutory review of quality assurance in ETBs similar to the process in place with Third Level institutions. Further updates will be provided.
- ✓ The Expression of Interest Process for a premises capable of integrating current Further Education and Training Provision in Nenagh was advertised and a decision on the next stage is expected by Christmas.
- The CE and Director of OSD met with Tipperary County Council and the Local Enterprise Office regarding the application for Tipperary Innovation Engine being submitted to Enterprise Ireland under the Regional Enterprise Development Fund 2017-2020. Tipperary ETB aim to have a stronger presence in in the delivery of FET programmes in Tipperary Town.

Mr. Frank Bermingham addressed the OSD Report, advised of the following key matters:

- ✓ The C&AG audit is almost concluded. TETB has responded to the main queries raised by the C&AG. The Management Report will be provided to TETB for response in due course.
- ✓ A number of capital projects are on-going, including the second phase of the temporary classrooms in Newport and temporary ASD accommodation in Cahir. However, there appears to have been a slow-down in project approval from the Department recently and a cut in the Education Capital allocation for 2020 was announced in the Budget. There is a concern that this may have an impact on existing and future projects needed in TETB. Mr. Bermingham hopes to arrange to meet with senior DES staff in the coming months to discuss funding/allocation.
- ✓ The Year to Date Financial Report that had been circulated to all for their consideration was taken as read, queries/observations were requested but none were forthcoming.
